You can choose either option and you still come out with the same grades as if you took any other A level.

For instance if you got an A* taking the **CACHE triple award**, that would mean that you get the equivalent of **3 A* at A level**.

This is <u>worth the same amount of UCAS points</u> towards university as if you had taken Maths, Physics and Chemistry!




